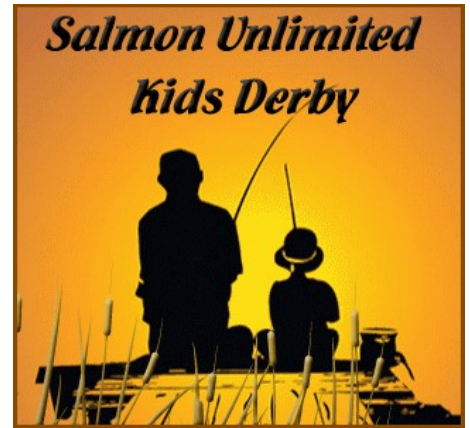




Salmon Unlimited Kids' Shore Fishing Derby

FREE to all kids, 18 and under. Ages 13 and under must have an adult guardian.

Divisions: Kids: Ages 13 and under.

Young Adults: Ages 14 to 18. **Young Adults 16 & older require a valid fishing license and salmon stamp if you plan to fish for salmon.**

Prizes: Prizes will be awarded for the largest fish of each species in each division. Any species can be entered. If it has fins, it can win!

Food: Lunch and drinks will be provided on the patio for all Participants.

Rules: Registration/check-in will start at 6am at the Harbor Office Patio. Fishing period will be from 7am to 12pm. All fishing must take place within the **designated areas** of Waukegan Harbor including Government Pier. All fish must be taken with hook & line in accordance with Illinois DNR regulations. **NO SNAGGING!** *Please* observe the harbor rules of no casting in the portion of the harbor where boats are moored.

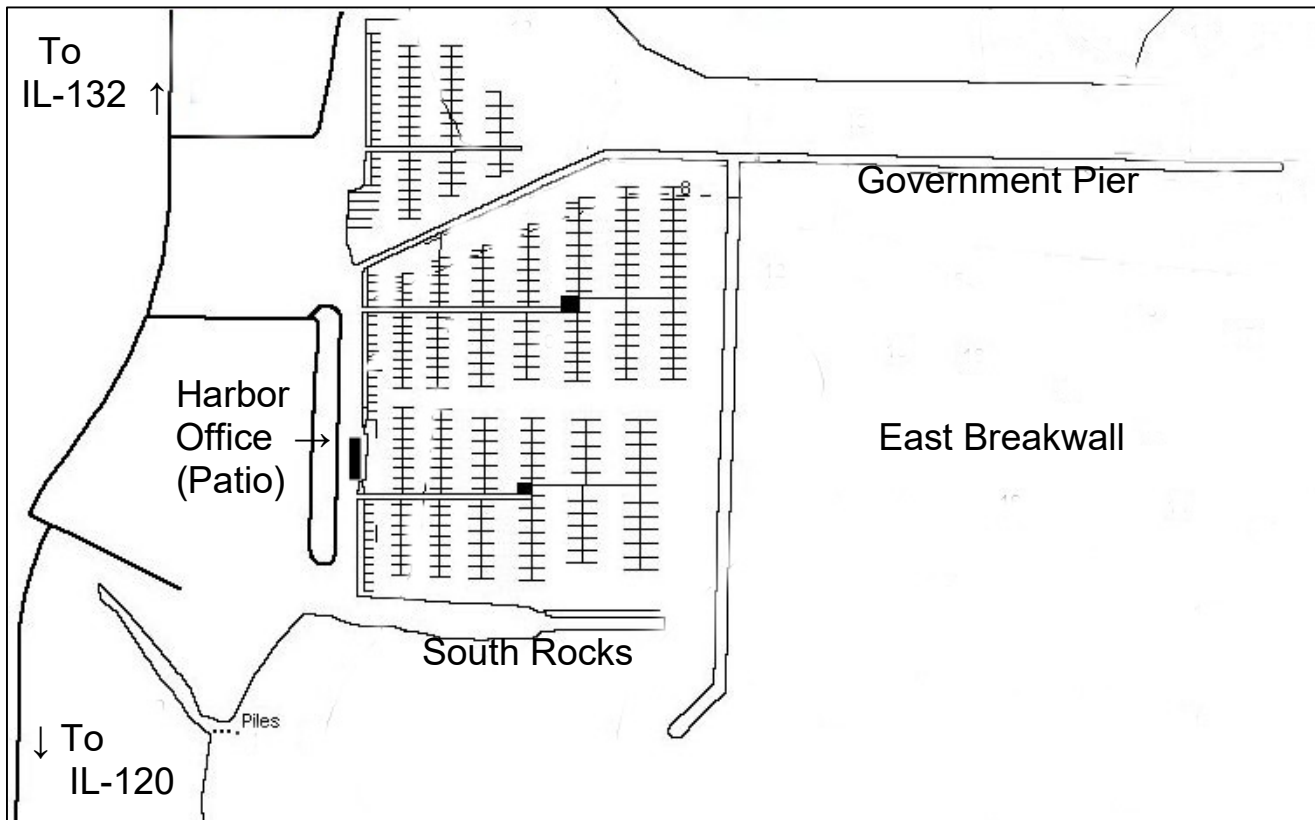

- All Participants, who are fishing and are 16 years old or older **MUST** possess a valid Illinois fishing license, per Illinois DNR regulations.
- Prizes awarded for the largest fish are limited to one prize per Participant. If a Participant catches the winning fish in more than one category, they will be awarded the higher prize, while the 2nd place angler will win the other prize.
- All decisions of the tournament committee with regards to the awarding of prizes shall be final.
- Salmon Unlimited, Inc. and its tournament committee reserve the right to change the rules of this contest, if necessary.
